## Nordic meeting, 3-4 March 2014 in Reykjavik

---

DAEA has now 34 member organizations and 12 partner organizations.

In our strategy for 2012-2017 we decided to expand our activities by external funding. As a result of this DAEA is now participating in several EU-programs and we are doing projects for Danish ministries and the Danish Parliament.

---

### **ARALE - Awareness Raising for Adult Learning and Education**

2013-14 in cooperation with EAEA and ENAEA, Estonia.

Best practice examples from all over Europe has been collected and written down about:

- o How to target the general public
- o How to target specific target groups
- o How to target policy-makers

and in October 2013 a conference was held in Bruxelles. Around 70 participants from 22 countries – EU countries, Japan, Israel – were present and Per Paludan Hansen, EAEA President, and Dana Bachmann, Head of vocational training and adult education Unit, European Commission, took part in the final panel discussion on “Do we need a European-wide campaign on adult education?” The answer was clearly 'yes'.

### **OED - Outreach Empowerment Diversity**

2011-14 in cooperation with EAEA and 15 other organizations.

DAEA is partner in this European project which maps best practice methods for inclusion of marginalised groups, especially migrants and ethnic minorities, for the development of more diversity in adult education, and especially the inclusion of learners' voices, and for the empowerment of its learners to become active European citizens.

The network will improve approaches in reaching out to disadvantaged groups, promoting diversity in organizations, improve teaching methodology, promote active citizenship by



participatory strategies and support the development of better policies aimed at integration and lifelong learning.

**AE-PRO / European Adult Education (young) Professionals Learning Platform**  
2014-16 in cooperation with EAEA and 7 other organisations.

The project is a Grundtvig project, Lifelong Learning programme (LLP project) and has just started.

In 2011 and 2012, EAEA offered a Grundtvig in-service training on 'European Training for (younger) adult education staff. The training had three main objectives: introduce (younger) staff to European developments in adult education, encourage the learning of each other's organizations and systems and to encourage the networking and cooperation between them. Both trainings were a big success and have filled a real need. We see a bigger need across Europe to learn more about European developments and other countries.

Another aspect of the project is the better and more coordinated use of Grundtvig mobilities, which will be necessary in the new programme generation now that staff mobility is the one mobility left for adult education. It is essential that more organization sign up to high quality exchanges and visits and that more younger staff members participate in it.

The main objective for the project is therefore the professionalization (and quality) of staff.

The Danish Institute for Non-formal Education (Vifo) is established by the Danish Ministry of Culture on a three year appropriation from January 2013.

Vifo is a part of the Danish Institute for Sports Studies – an independent research and knowledge centre set up by the Danish Ministry of Culture.

Vifo will primarily focus on non-formal adult education and non-formal youth and children leisure activities such as the scout movement, political and religious youth organisations.

Vifo's tasks are to:

- Create an overview of and insight into the area of non-formal education (folkeoplysning)
- Analyse the area of non-formal education
- Initiate public debate on central questions related to the area of non-formal education
